The registration fee is charged to each laboratory in each quarter. Renewal is done on 1<sup>st</sup> April every year.

User from outside is not charged registration fee in case who is a collaborate-researcher of CADIC teaching staff, and who use the IDRU temporarily and do experiment being accompanied by the CADIC staff. When user from outside requests to use IDRU independently (without being accompanied by CADIC staff) and create an authentication ID card, the user is charged the registration fee above. In such case, please contact to IDRU management office in advance.

Also, use of BSL3 unit for educational purpose and safety management is not charged.

## ● Temporally use

In case a user outside from the university uses IDRU to attend seminars or lectures for one day or more, registration fee of 1,500 yen/person/seminar will be charged.

## ● Expense for specific equipment

User is able to use the machine above (QIAcube) with only paying the usage fee above. All reagents and consumables required must be prepared by each user.

### [Procedure required]

Please submit the Application Form one week before the date that user would like to use. Attendance to the educational lectures for pathogen-handling and/or genetic modification experiment organized by the university is required, if user would like to handle samples containing pathogens/genetically modified organisms via the machine (QIAcube). Appropriate relevant procedures are also needed according to the University restrictions. In such cases, please contact to the IDR management office in advance. For first time use, please contact to the Laboratory of Veterinary Parasitology before making reservation through web reservation system.
